Changes to Extractable Nuclear Antibody Testing

Test code **ANASCN** will be retired and replaced with test code **ENA**, Extractable Nuclear Antibodies. This test will collectively screen for the following extractable nuclear antibodies: Sjogren's Antibody A (SSA), Sjogren's Antibody B (SSB), ScI-70, JO1, Smith Antibodies (Sm), and Ribonucleoprotein (RNP). If positive, the test will reflex and report the individual assays. Individual test components can also be ordered singly; please consult the online <u>Test Reference</u> <u>Manual</u> for test names, test codes and a suggested testing algorithm.

New Test Codes

Test code: **ENA** Description: Extractable Nuclear Antibodies

Test code **SMRNP**, SM-RNP Antibodies, will be retired and replaced with new test codes **RNP** and **SM**.

Test code: **RNP** Description: **RNP/SmRNP Antibodies** (RNP and SmRNP antibodies)

Test code: **SM** Description: **Smith Antibodies** will test for Smith Antibodies only

Changes to Toxicology Drug Panel Structure

Effective December 11, 2021, there will be a change in the reporting structure of toxicology drug panels (not rapid testing). Initial immunoassay screening results will be reported immediately after testing without a delay to perform confirmatory testing. All drug screens will be reported as either "Negative" or "Presumptive Positive". Drug classes reported as "Presumptive Positive" will include a comment indicating that confirmatory testing is pending and will be reported separately. Confirmatory results will be reported 24-48 hours later.

The affected toxicology drug panels include DAS, PCS10, MINDAS, PCSMIN, BHDAS and OPI.

Single drug class screens that reflex to confirmation, including test codes AMP, BAR, BENZ, BUP, CAN, COC, METD, OPIMIN and OXY, will be structured similarly.
